4	MS. HULL: Your Honor, we're here before the
5	Court today with the State of Georgia versus Keith
6	Duncan. It's Warrant Number 2011-MGNW-3443-F.
7	He's here for the offense of Aggravated
8	Stalking.
9	This is a 10-Day Hearing pursuant to O.C.G.A.
10	17-6-1 Subsection 12. For the offense of Aggravated
11	Stalking, there is no bond.
12	This offense occurred on and about August the
13	31st of 2011. In between that on September 1st of
14	2011, the arrest date for Mr. Duncan, as it shows
15	will be October the 24th of 2011.
16	Is that correct, Mr. Duncan?
17	DEFENDANT DUNCAN: No, it was October 3rd.
18	MS. HULL: Where were you arrested at?
19	DEFENDANT DUNCAN: Las Vegas.
20	MS. HULL: Okay. And he was brought here and
21	he actually arrived in the Cherokee County Jail on
22	October 24th of 2011; is that correct?
23	DEFENDANT DUNCAN: To the best of my
24	knowledge.
25	THE COURT: All right.

1	MS. HULL: Mr. Duncan, if you would please
2	raise your right hand.
3	(Whereupon, the Defendant was duly sworn by
4	Ms. Hull.)
5	THE COURT: All right then. Mr. Duncan, how
6	old are you?
7	DEFENDANT DUNCAN: 53.
8	THE COURT: How far did you go in school?
9	DEFENDANT DUNCAN: Bachelor of Science in
10	Computer Science.
11	THE COURT: Can you read and write?
12	DEFENDANT DUNCAN: Yes, sir.
13	THE COURT: Are you under the influence of any
14	alcohol or drug at this time?
15	DEFENDANT DUNCAN: No, sir.
16	THE COURT: Is anybody here with you today?
17	DEFENDANT DUNCAN: I've called three different
18	lawyers to be here and they're not present.
19	THE COURT: Okay. You don't have any family
20	present?
21	DEFENDANT DUNCAN: No, sir.
22	THE COURT: All right. Do you understand what
23	you're charged with?
24	DEFENDANT DUNCAN: Actually, no, sir.
25	THE COURT: Well, you've got two cases.

1	One, is it looks like it's Stalking, which
2	is a misdemeanor.
3	The other is Aggravated Stalking on August the
4	31st of 2011. I'm not going for most of these
5	for one of these offenses there is a bond set by
6	schedule posted in the jail.
7	For the second offense, Aggravated Stalking,
8	there is no bond except when the Superior Court
9	Judge sets bond. And I'm a Superior Court Judge, I
10	can do that, but I would not do that at this time.
11	I will consider that when somebody files a Motion
12	for Bond in your behalf. Right now all I'm going to
13	do is advise you of your rights.
14	Do you understand that?
15	DEFENDANT DUNCAN: Yes, sir. Is there going
16	to be evidence?
17	THE COURT: No, you don't need to submit
18	evidence. I'll get to that in just a minute and see
19	what you want to do. But right now all I'm going to
20	do is advise you of your rights.
21	You have a right to remain silent, anything
22	you say can and will be used against in court.
23	Do you understand that?
24	DEFENDANT DUNCAN: Yes, sir.
25	THE COURT: You have a right to have a

1	indictment by the Grand Jury. The next time the
2	Grand Jury could possibly meet to consider your
3	indictment would be the second Monday in November.
4	That would be this next coming this coming Monday
5	no, let's see, that would be Monday week, I guess
6	wouldn't it?
7	MS. HULL: Right.
8	THE COURT: Monday week. You have a right to
9	have a Pre-Indictment Probable Cause Hearing. If
10	you wait until after indictment it will be to late
11	for that hearing.
12	You have a right if a bond is set in your
13	case and you make bond, you give up your right to
14	that hearing.
15	You have a right to a trial by jury.
16	Probably more importantly than anything else
17	I've told you is you have a right to have a lawyer
18	represent you. If you cannot afford one, one would
19	be appointed for you at no expense to you.
20	Now, you just told me you'd called three
21	lawyers. Do you have a lawyer?
22	DEFENDANT DUNCAN: I don't have one under
23	contract at this point because of the timing.
24	THE COURT: Or do you need one appointed? It

doesn't matter why. Do you need one appointed?

1	DEFENDANT DUNCAN: No, sir.
2	THE COURT: You don't need one appointed?
3	DEFENDANT DUNCAN: I'll have one private.
4	THE COURT: All right. You understand the
5	longer you wait to get a lawyer the less likely they
6	can do you any good?
7	DEFENDANT DUNCAN: I'm going to obtain a
8	lawyer as fast as I can, sir.
9	THE COURT: All right. I'm just telling you.
10	If you need one appointed and you cannot afford one,
11	the Court will appoint you one at no expense to you.
12	Do you understand that?
13	DEFENDANT DUNCAN: I can afford one.
14	THE COURT: All right. You have a right to
15	have a trial by jury.
16	If at any time you want to give up the rights
17	I told you about and want to enter a plea of guilty
18	then you'd notify your lawyer or the sheriff who has
19	you in custody and you'd be brought back before the
20	Court for such a plea.
21	Any questions?
22	DEFENDANT DUNCAN: Yes. Can I have what you
23	read to me in writing please?
24	THE COURT: No.
25	DEFENDANT DUNCAN: Okay. I would also like to


1	THE COURT: I don't know. I have no idea.

18	lawyers to do that, including my private lawyer
19	Jimmy Deal in Norcross, Georgia. He has all the
20	evidence against it. I have physical records. And
21	particularly if I may address the Aggravated
22	Stalking.
23	He lives in a gated community
24	THE COURT: (Interposing) You mean the Mr.
25	Rose does?

1 DEFENDANT DUNCAN: Mr. Rose. And I have not been in Cherokee County for nine months. /1/2 wes THE COURT: Well, it won't matter because 3 they're saying you did it by telephone and that can 4 5 be -- the venue for a telephone call is where the call is received. So, if you made a phone call to 6 7 him that might be enough. I don't know what they're 8 saying here. 9 DEFENDANT DUNCAN: They're saying email 10 contact. 11 THE COURT: Well, that's the same thing. 12 DEFENDANT DUNCAN: And I'll go on the record 13 saying that he has my email password. You can also fabricate emails against me. He's a very high 14 15 technology guy. So am I. 16 THE COURT: Okay. Well, that's all 17 interesting stuff and it may be useful. I don't 18 know what the -- I can't do anything for you. I 19 can't check this out for you. That's what your 20 lawyer does and the DA may want to check this out 21 for purposes of evaluating their case and/or 22 notifying Sally Yates. 23 You know, if she hasn't called you back, she 24 may not be interested. I don't know. I know who

she is I've met her. But that's all I can tell you.

1	DEFENDANT DUNCAN: I've also called the F.B.I.
2	and interviewed with them and the I.R.S. as well. I
3	called the F.B.I. guy last Wednesday and Friday.

10	MS. HULL: With who?
11	DEFENDANT DUNCAN: With Janet. She is the
12	desk agent.
13	MS. HULL: Her last name?
14	DEFENDANT DUNCAN: She won't reveal those.
15	They can't. The F.B.I. can't give their last names.
16	MS. HULL: So, you're stating right here in
17	court today there is a case pending against Mr. Rose
18	in Federal Court and you say that you're a witness?
19	DEFENDANT DUNCAN: That's correct. I've been
20	subpoenaed to provide evidence last week against
21	Robert Rose.
22	MS. HULL: Do you have a copy of your
23	subpoena? Fulton (to Oct 25 2021)  Cyclone cavey us Robert Der Rose  DEFENDANT DUNCAN: I don't have it with me. RICO
24	DEFENDANT DUNCAN: I don't have it with me. RICO
25	THE COURT: You said you're saying Federal

1	but you're also saying Fulton County.
2	DEFENDANT DUNCAN: It was in Fulton County.
3	It's the Federal Court, Cutty versus Robert Rose
4	federal racketeering against him and his wife Amy
5	Rose.
6	THÉ COURT: Well, you understand this may or
7	may not help you because even a criminal Defendant
8	can't arguably be subject to court protection?
9	DEFENDANT DUNCAN: I understand.
10	THE COURT: If he was if he obtained a
11	Stalking Order against a creditor, creditors have
12	limitations, too. You say he owes you money and
13	arguably if you were he can say you were
14	harassing. Fursyth Cty Judsment 0856-1345
15	DEFENDANT DUNCAN: His company owes me money.
16	THE COURT: Well, you see what I'm talking
17	about? It may or may not help you.
18	Do you understand that? You definitely need
19	to be talking to a lawyer. It may or may not help
20	you.
21	DEFENDANT DUNCAN: Yes.
22	THE COURT: Okay.
23	DEFENDANT DUNCAN: Was this sufficient
24	evidence? Anything else I can add?
25	THE COURT: No, no. You're not required to

1	give me anything. So, anything you're telling me is
2	I'm just the reason I asked is because you
3	wanted to do it.
4	DEFENDANT DUNCAN: Yes, sir.
5	THE COURT: And it may or may not affect what
6	the District Attorney does. They may decide they
7	don't want any part of it or they may decide that
8	they can use this information to build their case
9	better against you.
10	They're authorized to do that.
11	DEFENDANT DUNCAN: Yes.
12	THE COURT: So, I'll have to leave it up to
13	them as to how they want to handle this.
14	DEFENDANT DUNCAN: Understood, sir.
15	THE COURT: All right. Anything else?
16	DEFENDANT DUNCAN: I also have enough evidence
17	to say that he's bribed Federal, State and County
18	local Judges.
19	Indse Fronk Mils THE COURT: See, about the only way you could
20	know that is if you're involved in it, too.
21	DEFENDANT DUNCAN: I'll use the word friend

17	please?
18	THE COURT: Go ahead.
19	DEFENDANT DUNCAN: The investigator Jill Gian-
20	
21	THE COURT: (Interposing) Gianfala probably.
22	DEFENDANT DUNCAN: Has an email that he sent
23	me saying that when I purposed that there might
24	be something going on with Robert Rose and I use the
25	coercing or pressuring Cherokee County, there's an

1	email approximately September 15th where he emailed FBI GRI, Press
2	me saying for me not to notify anything authorities
3	to investigate Cherokee County. That Cherokee
4	County would be doing any internal investigation
5	themselves. It's a email September 15th.
6	THE COURT: Okay.
7	MS. HULL: Give that to your attorney and then
8	your attorney can give that to me.
9	DEFENDANT DUNCAN: Yes, ma'am.
10	THE COURT: Okay. All right. Anything else?
11	DEFENDANT DUNCAN: That's it, sir.
12	THE COURT: All right. Good luck.
13	DEFENDANT DUNCAN: I appreciate your patience.
14	THE COURT: All right. And this my I'm
15	Judge Mills and this is my Court Reporter. You can
16	contact my office or this Court Reporter, Ms.
