1                    WILLIAM BANKS, was sworn and testified before  
2 the Grand Jury as follows:

3  
4                    EXAMINATION

5 BY MR. BRADENHAM:

6                    Q        Good morning.

7                    A        Good morning.

8                    Q        Would you state your full name and  
9 occupation?

10                   A        William Banks. Senior Special Agent with the  
11 Bureau of Alcohol, Tobacco, Firearms and Explosives.

12                   Q        What is it the Bureau of ATF does other than  
13 get its name in the newspaper for instances in Arizona?

14                   A        We're responsible for investigating the  
15 Federal firearms and narcotics violations.

16                   Q        I have read the grand jury this particular  
17 indictment on Keith Brent Duncan.

18                          Are you familiar with the facts and  
19 circumstances of this case?

20                   A        Yes, sir, I am.

21                   Q        Have you read reports, interviewed  
22 individuals who are connected to that to prepare your  
23 testimony here today?

24                   A        Yes, sir, I have.

25                   Q        Have you reviewed the proposed indictment?

1 A Yes, sir, I have.

2 Q Do you feel that the facts that are alleged  
3 in there can be proven with evidence in possession of  
4 the United States Government?

5 A Yes, sir.

6 Q From your research, Agent Banks, the incident  
7 that I am going to ask you about occurred late in the  
8 evening on September 25th through the, I guess, early  
9 morning hours of September 26, 2011 at Langley Air Force  
10 Base; is that correct?

11 A That's correct.

12 Q Is that within the Eastern District of  
13 Virginia?

14 A It is.

15 Q What information have you become aware of  
16 that is the basis for the indictment against one  
17 Keith Brent Duncan?

18 A A quick overview is that on September 25th of  
19 this year, at approximately 9:47 p.m., Keith Duncan was  
20 reported to the Air Force Security Forces at Langley Air  
21 Force Base as a suspicious person that was at the West  
22 Gate entrance to Langley Air Force Base. Police were  
23 dispatched to the gate, and they made contact with  
24 Duncan.

25 Duncan verbally stated that he had

1 information vital to national security. At that point  
2 Security Forces called the Air Force Office of Special  
3 Investigations. An agent from that office was sent to  
4 the gate. Mr. Duncan gave verbal consent to the search  
5 of his vehicle and told the individuals that he had a  
6 shotgun and several bladed weapons in the vehicle. They  
7 did a National Crime Information Center, or NCIC, check  
8 on the individual regarding Duncan, and it revealed that  
9 he had a protective order that had been issued to him  
10 from the state of Georgia. Duncan was prohibited from  
11 possessing a firearm under Federal law.

12 He was issued a summons for illegal  
13 possession of a firearm, and the Security Forces  
14 individuals took the shotgun into their possession. He  
15 was denied entry to the installation and was sent on his  
16 way.

17 He had been issued a protective order for  
18 stalking in the state of Georgia, the County of Cobb, on  
19 February 12, 2011, and that order remains in effect  
20 until February 22, 2012.

21 Q Under Federal law, in particular Title 18  
22 Section 922(g)(8), does that specifically prohibit  
23 individuals that are under a protective order from  
24 possessing firearms; is that correct?

25 A That's correct.

1 Q Individuals that are under protective  
2 orders. It's not necessary they be convicted felons in  
3 order to be prohibited from possessing firearms?

4 A That's correct. It's like the domestic  
5 violence charge.

6 Q And the stalking, 12-month protective order  
7 issued against Keith Duncan by the Superior Court for  
8 the county -- what was that county --

9 A Cobb, C-o-b-b, yes, sir.

10 Q -- in the state of Georgia? That was in  
11 existence on September 25, 2001; is that correct?

12 A Yes, sir, that's correct.

13 Q Information has been gathered in the  
14 investigation that the defendant Keith Brent Duncan  
15 appeared in court in Georgia and had notice of this  
16 particular order; is that correct?

17 A That's correct.

18 Q And he had an opportunity in that Court to  
19 participate and offer any kind of explanation to that  
20 particular judge in the Superior Court of Georgia; is  
21 that correct?

22 A That's correct.

23 Q The type of firearm that was recovered in the  
24 vehicle belonging to Keith Brent Duncan, can you  
25 describe that?

1           A     Yes, sir. It was a Springfield double-barrel  
2 shotgun, 16-gauge caliber.

3           Q     Was that firearm loaded or unloaded?

4           A     That I do not know. The order that I have,  
5 sir, in front of me from Security Forces does not state  
6 whether it was loaded or unloaded.

7           Q     Have you checked the origin of that  
8 particular firearm? Are they manufactured outside the  
9 state of Virginia?

10          A     That's correct.

11          Q     And therefore prior to September 25, 2011,  
12 this particular Springfield 16 gauge double-barrel  
13 shotgun traveled in interstate commerce from the state  
14 it was manufactured to the state of Virginia; is that  
15 correct?

16          A     That's correct.

17          Q     Where are Springfields manufactured,  
18 Agent Banks?

19          A     I haven't analyzed and looked at that weapon  
20 specifically. The police report that Langley Air Force  
21 Base sent over just said that it was a Springfield.  
22 They did not have -- the report that came over from  
23 Langley said it did not have a serial number. That  
24 doesn't mean it didn't have one. They may not have  
25 known where to look. I haven't physically examined the

1 weapon yet. So I can't answer exactly where it is  
2 because there were different shotguns produced in  
3 certain different locations but all outside the state of  
4 Virginia. Until I have a chance to physically examine  
5 the weapon, I can't answer that.

6 Q From your intimate knowledge, there are no  
7 manufacturers in the state of Virginia that manufacture  
8 Springfield shotguns?

9 A That's correct.

10 MR. BRADENHAM: Any questions of Agent Banks  
11 that I may have overlooked?

12 A GRAND JUROR: Was the person that the peace  
13 warrant -- who took out the peace warrant, were they on  
14 Langley?

15 THE WITNESS: No. Actually, it looks like  
16 they reside in Georgia.

17 BY MR. BRADENHAM:

18 Q The protective order that you just recited  
19 originated in the Superior Court for the County of Cobb,  
20 for Georgia. So a Georgia judge issued the protective  
21 order against Keith Brent Duncan based on an event that  
22 occurred in the state of Georgia; is that correct?

23 A That's correct.

24 MR. BRADENHAM: Yes, sir.

25 A GRAND JUROR: So this guy just drives up to

1 Langley Air Force Base telling the police that he has  
2 information of national security thinking he's doing  
3 good. They find the gun, run the check and --

4 THE WITNESS: That's correct.

5 BY MR. BRADENHAM:

6 Q His unusual presentation and unusual request  
7 brought him to the attention of the Federal protective  
8 service people; is that correct?

9 A What happens is: Right now at Langley Air  
0 Force Base -- you go to Langley right now most of --  
1 it's hit or miss, but most of the security checkpoints  
2 are run by contract personnel.

3 So when this individual presented himself in  
4 that manner, they first called Security Forces.  
5 Security Forces responded, which is the Military Police.  
6 Then the guy says that he has information vital to  
7 national security. They are not going to deal with  
8 that. They are going to call OSI, Office of Special  
9 Investigation. You don't know what it is. So that's  
0 what they did. They called. Then at that point  
1 Air Force OSI and Security Forces dealt with the  
2 incident.

3 Q And finding a shotgun in the man's car, did  
4 not waylay their thoughts about this case; is that  
5 correct? ↗ *What did Grand Jury Foreman mean?*



1 A That's correct.

2 MR. BRADENHAM: Any other good questions of  
3 Mr. Banks?

4 **FALSE**

5 A GRAND JUROR: I am just curious to know.  
6 He's prohibit from having a firearm because of the  
7 protective order, but he's allowed to carry knives?

8 THE WITNESS: Yes, ma'am. There's no -- as  
9 far as the Federal statute, the Federal statute just  
0 carries firearms.

1 MR. BRADENHAM: You'd be surprised what  
2 people carry as we learn. As we learned earlier, even a  
3 beer vendor. Thank you.
