Section 16-5-91 STALKING AGGRAVATED(F), between on 8/31/2011 at 11:00 PM and on 9/1/2011 at 12:00 PM at 106 Liberty Grove Pass, Alpharetta in the County of Cherokee, Georgia, for that said accused, Duncan, Keith Brent, did stalk another person, Rose, Robert Dee, at a place, 106 Liberty Grove Pass, Alpharetta, Georgia, without the consent of that person for the purpose of harassing and intimidating that person, in violation of a court order, to wit: Said accused sent an e-mail contact to the victim in violation of protective order.
