



STATEMENT :

Most FORMAL legal request is for Senator David Purdue to immediately CALL FBI + AG and command they contact Keith Duncan and PROTECT my life from these cyber crime terrorist network organizations. ROSE infiltrated the USA GOV at many levels back in 2008 and was reported TO these same top agencies multiple times starting summer 2008. These crimes are all solved and prevented forever by world changing EVOTE.ONE. FOIA.ONE. SolutionMilitary.com SolutionManifesto.com = SolutionPeace.com CONGRESSIONAL INVESTIGATIONS into FBI + AG massive CORRUPTION must occur also.

Keith Duncan is 100% victim of organized crime cyber terrorist Robert Dee Rose as showcased by famous TheFinalTerrorist.com and client3635.wix.com/manhuntrose ROSE has a \$2 Million USD bounty reward on his head for years from IRS Whistleblower Feb 2009, 658. The FBI and AG offices have clearly 'blacklisted' me' to PREVENT any and all criminal investigations I completed from commanding arrests of over 85 persons tied to ROSE by their very own signatures and criminal evidence I collected in person for +11 years.

My life remains in extreme danger from ROSE since original Jan 2008 threats to my life per ROSEs failed attempts to recruit me as a cyber criminal based on my most extensive computer science tellicommunication architecture background since year 1976. My Marietta GA home was robbed of \$40,000 USD by ROSE and Ms. Bashama per Marietta P.D. 1.11.2506.99 on Feb 4, 2011.

ROSE paid off Cobb County DA Patrick Head, Grady Moore, my own lawyer (now DA) Berry Vic Reynolds to create criminally granted Temp Protective order 1.11.1171.99 on Feb 22, 2011. After 5 months, this TPO was dismissed July 15, 2011. Then everyone REFUSED to arrest Ms. Bashama and ROSE. Subsequent Cobb County TPO 11.1.7683.99 was criminally granted by Cobb County Judge on Aug 22, 2011 claiming I had stalked ROSE because I was actively turning over and visiting the IRS, FBI, AG, USMarshals, and had already go to International PRESS so so many times demanding Justice be served.

IRS Whistleblower Feb 2009, 658 was filed and granted BY my lawyer Vivian Hoard vHoard@taylorEnglish.com (770)541-2223, FBI was personally visited and debriefed along with IRS and USMarshalls and AG in Nov 2010 after Forsyth County final Judgment 08SC-1345 was granted Oct 2010 now worth over \$300,000. My own lawyer Jimmy Deal of Norcross, GA (770)263-7200 has all the evidence turned over to USA GOV. Jimmy was also extort bribed off by ROSE and faces prison.

Subsequently I was asked by retired Congressman Buddy Dardin (former Cobb County DA) to go direct to USA Military Air Force Intelligence Group Fall 2011 on SolutionMilitary.com as my life was in immediate danger from being cyber stalked BY ROSE. I arrived Langley AFB Base Sept 25, 2011 Sunday evening requesting re-admission during Monday business hours and was granted permission to return. One week later, after re-visiting AG Sally Yates in Atlanta and IRS, I am arrested on Oct 3, 2011 in Las Vega on FALSE CHARGES I had stalked ROSE Aug 31, 2011 by a single EMAIL I never sent and 2nd false charge back dated to Nov 2010 (BEFORE this TPO was GRANTED). I suffered extreme damage and emotional threats in Cherokee County Jail since FBI AG, my own lawyers, and family REFUSED to demand my immediate release INTO protective custody of AG. My own \$27,500 USD lawyer Ross Grisham (678)880-9360 and everyone involved KNEW I was illegally detained (kidnapped) and REFUSED to go to FBI AG to demand my immediate release. The 90 Day speedy trial law was violated then as well as Dec 13, 2011 to Jan 28, 2014 (read below).

On Dec 13, 2011 while I am being threatened in Cherokee County Jail, Georgia AG Sally Yates signs Norfolk VA 4:11cr112 Violation arrest warrant based on NO VIOLATION COULD HAVE OCCURRED Sept 25, 2011 since NO active TPO was in effect preventing me from owning demonstration, antique firearm in my trunk. ROSE had the first false arrest warrant issued Sept 26, 2011 9 am as I waited for re-admission to Langley Air Force Base Virginia based on OSI Capt Christopher Weber 3 hour previous night debriefing.

I was held total of 900 DAYS in HELL-JAIL, violating every one of my constitutional Rights to command investigations and arrests/seizure of MY assets from ROSE and my own DUNCAN clan.

While I am being criminally and illegally held Oct 3, 2011 to Jan 28, 2014, my entire lifetime fortune of \$1.2 Million USD is criminally sold off by a single forged Power of Attorney by murdered Brian Walker (Gwinnett cremation Dec 7, 2013) including my \$100,000 USD pre-paid condo, all my bank accounts, and my 401K retirement accounts cashed out to BRIAN and my own DUNCAN clan (ex -wife Sherry Duncan, two sons Matthew Vernon Duncan and Kyle Smith Duncan) and many others. I have already reported every criminal to ALL law enforcement this entire time. FBI and local law enforcement THREATEN me when I present these same certified court documents and demand they arrest each person based only on the criminals own signatures and false evidence ALREADY admitted into court evidence. Most of these documents have been sealed and most others destroyed and forged. These are ALL crimes committed to PREVENT what is left of our judicial system to obtain immediate JUSTICE and recompensation for the horrific red paper chase crimes committed against myself.
